## **Chairperson/President's Report**

Throughout 2024, WyHy Federal Credit Union proudly celebrated 70 years of service and commitment since its founding in December 1953. The year concluded with significant milestones, including \$389,583,837 in assets, \$336,751,274 in shares, and \$293,196,097 in loans. By year's end, WyHy served 22,232 members with the help of 54 dedicated employees across its branches in Casper, Cheyenne, Green River, Rock Springs, and Lyman, reinforcing its longstanding mission of supporting Wyoming communities.

### **Supervisory Committee Report**

The Supervisory Committee, appointed by the Board of Directors, is responsible for reviewing and evaluating operations to ensure the accuracy and completeness of WyHy's records. Their work ensures that transactions are properly recorded and assets remain secure. Comprised of dedicated volunteers, the committee meets monthly to oversee audits and address member concerns.

Given the scope of WyHy's operations and the range of services provided, the Supervisory Committee engages the firm of Petersen and Associates to perform essential agreedupon procedures and audits. This includes three interim reviews and an annual opinion audit.

#### **Community Service**

WyHy is deeply committed to supporting not only our members but also the communities we serve across Wyoming. Each month, we carefully review and consider donation and sponsorship requests from both our members and the public, providing assistance through financial contributions as well as the dedication of our time.

In 2024, WyHy proudly supported more than 40 charities and organizations statewide, contributing over \$62,000 to strengthen and uplift local communities. Highlights from the year include WyHy team members building homes with Habitat for Humanity, demonstrating our hands-on commitment to community development. We also supported organizations such as Cowboys Against Cancer, Jason's Friends, Meals on Wheels, and the Field of Remembrance. Additionally, we invested in educational initiatives by partnering with local schools to fund programs that inspire and empower Wyoming's youth. These efforts demonstrate our unwavering commitment to creating a brighter future for Wyoming.
